Michael Cardozo, Esq.



Michael Cardozo is the Corporation Counsel of the City of New York. As Corporation Counsel, he is the Chief Legal Officer of New York City and oversees a Law Department with more than 650 attorneys in 17 different divisions. Only one law firm in all of New York City employs more lawyers. In fact, the New York City Law Department is the second-largest public law office in the entire United States. The Office of the Corporation Counsel provides legal services to the Mayor, the City, the City's agencies, and related entities, such as the Board of Education and the Health and Hospitals Corporation.

Mr. Cardozo is a 1966 graduate of Columbia Law School, where he served as an editor of the law review. He received his undergraduate degree from Brown University in 1963. After serving as a law clerk for the late Judge Edward C. McLean in the U.S. District Court for the Southern District Court of New York, Mr. Cardozo joined the law firm of Proskauer Rose as an associate in 1967. He became a partner in 1974.

Mr. Cardozo is the Chair of the Columbia Law School Board of Visitors. In addition to being a member of numerous bar associations, he is a member of the Board of Directors of the Lawyers Committee for Civil Rights Under Law, the American Law Institute, the Board of Trustees of the Federal Bar Council, and the Executive Committee of the Lawyers Division of the Anti-Defamation League. He previously served as Chair of the Fund for Modern Courts, Chair (by appointment of Governor Cuomo and Chief Judge Wachtler) of both the New York State Joint Committee on Judicial Administration and the New York State Task Force on the Appellate Divisions, and, in the mid-1970s, as counsel to Governor Carey's Task Force on Court Reform.

NYRF News – 9/11 Grants

During the last meeting of the board of trustees, under the new chairmanship of Morton Eydenberg, following grant requests were approved:

\$100,000 for Project Hospitality,

an organization that was instrumental in providing housing and food for Staten Island emergency workers during and after 9/11.

\$35,000 for four individuals (three approved for \$10,000 and one for \$5,000). These individuals have, in one case, lost the husband, in the other cases lost their jobs and/or haven't gotten injured during 9/11.

Our total disbursed monies out of this fund are now \$1,13 Million and leave another \$340,000 for distribution.
