Dear Rotarian Vieta:

The Board of Directors of Rotary District 7230 NYC/WTC Disaster Relief Fund, Inc. is pleased to announce that they have approved a grant, to the Rotary Club of New York City for the "September 11, 2001 Children's Fund, Inc. in the amount of \$150,000.

A \$75,000 check is enclosed as first payment for the program. The second and final check will be forwarded after we receive a report of how the initial \$75,000 was used along with the proper back-up information—a list of the children currently enrolled or registered in schools.

The Rotary Club of New York City will be responsible for administering and being accountable for these funds. The check cannot be turned over to a third party. Your Club is responsible to ensure monies used are for the purposes defined in your Club's application - for the children of victims of the World Trade Center Disaster; any funds not so used must be returned immediately.

Additionally, your Club is responsible for evaluating the results of the monies allocated. Your Club is to provide the NYC/WTC Fund with a comprehensive report of the program and how the funds were used, by December 15, 2003 along with a complete list of children enrolled or registered in schools.

Due to the nature of our program, where a death certificate is not available, the New York City Rotary Club is to verify and document by Affidavit, that the participant/s are indeed children of the deceased World Trade Center victims.

Any publicity regarding this grant, should mention the Rotary District 7230 NYC/WTC Disaster Relief Fund, Inc.

Many contributors have asked us to publish letters received from the children. If you do receive any letters, we ask that you forward them to us, with permission to publish, if their name is used. Thank you for your cooperation.
